There will be 2 special orders of business at the September 17th regular meeting which will be held at the Union Hall. At that time, we will hold nominations and elections for four positions that will be held by union members for the building committee. Those four individuals will be in addition to those members who are automatically on the committee (the corporation members as well as the JATC trustees). This committee will assist in determining if we will purchase a building with enough existing parking and modify it or if we will purchase a piece of property on which to build from scratch. As most of you are aware, the membership has already made the initial \$.10 contribution to the JATC to help fund this endeavor. The concept is that an additional \$.10 per year will be allocated the next 2 years, and that should create enough money to pay off a mortgage within 15 years.

At the same meeting, there will be a nomination and election of the conductor. Previously, at the regular election, no one ran for that position, and we need to be sure to fill it in a timely manner.

At the last regular meeting, we discussed that there may be a need for workers in the state of Massachusetts. The State of Massachusetts now, like the state of Connecticut, requires that workers who perform the tasks performed by sheet metal workers hold a state license. Local #83 will be providing a class for those members who are unemployed and willing to take work in Massachusetts. Upon completion of the class as well as signing up, taking and passing the licensing exam, the body voted to reimburse the members the out of pocket cost for the exam and getting the license. Additional classes that shall be offered by the local will be noted in other portions of this newsletter.

We are still selling Steak Bake tickets, and so far, not many have been purchased. Keep in mind that the body passed the vote that if a member purchases a \$40 ticket and attends the Bake, they will be reimbursed for the price of their ticket. We strongly encourage the members to participate. Everyone has a great time. Where else can you eat lunch and dinner, play games and walk away with a door prize (minimum value of \$10) and drink soda and beer on tap all day? Consider bringing friends and family! <u>General</u>

The local continues to request that members update us on their change of address, phone numbers and email addresses. We continue to request that all members provide us with their email addresses in an effort to save on postage and so that they will receive information more quickly.

<u>HRA</u>

As a result of the fund prospering in 2014, the insurance fund trustees made the decision that they would make a contribution to those members with coverage in the amount of \$4.00 per hour for every hour over 1400 worked in 2014.

This was supposed to be effective September 1, 2015. Just before that date, the fund found out there were a number of issues and tasks that needed to be done before the members could access their monies for reimbursement via the internet. A lot of data needed to be hand entered as well as programming changes. Unlike most HRA or HSA plans, we have, in the past, allowed the monies to be used for the claims from the year that had passed. This will be allowed again so the members can submit their claims for reimbursement of expenses incurred in 2014. There have been computer glitches, and unfortunately the ability to submit claims online is still not up and running but should be shortly. We will post that info on the Web once we know the exact date. The good news is that you can submit your claims via the regular mail right now, and you should be able to file for reimbursement via the internet by 9/14/2015. Those claims forms are also available on our website.

Note: a notice will be mailed out shortly telling you how much was contributed to your account for the 2014 period.
