Per Article Sixteen (16), Section Thirteen (13)(c), any member who has his or her dues paid through April 2021 and is thus not suspended may vote in the 2021 SMART Local 83, Local Union Officers election. Identification by dues receipt, picture ID or equivalent will be required.

Members not listed on the polling list or without proper identification may vote by challenged ballot.

****Local 83's utmost priority in all matters is the safety of the membership. The ongoing COVID-19 pandemic presents challenges to our ordinary in-person election procedures. Local 83 has devised an election plan that follows COVID-19 protocol's while preserving the right of members to elect leadership.****

COVID-19 ELECTION PROCEDURE PROTOCOL:

(These rules may change as CDC and NYS requirements are updated)

- Face Mask will be required inside election facility
- Must follow social distancing of six (6) feet while waiting in line to vote.
- There will be specific entrances and exits at both facilities.
- In Plattsburgh you will use paper ballot and pens will be provided and wiped down after each use.
- In Clifton Park you will vote electronically. The voting machine supplier asked that we provide Q-Tips to vote on the machines (no finger tips), you will dispose of the Q-tip after you vote and the machines will be wiped down periodically with Isopropyl Alcohol.
