On Monday May 22, 2023, at the Special Meeting, the body (49 members present) voted and allocated the \$2.45 rate increase due June 1^{st,} 2023. Listed below are the new rates.

*WORKING ASSESSMENT -- Local 83 Journeyperson Total Package (\$75.91) x number of hours worked x 2.0% + \$0.01 +\$0.20 per hour. or \$1.73 per hour.

*WORKING ASSESSMENT - Local 83 - <u>1st thru 5th year Apprentices</u> Total Package (Varies – see spreadsheet) x hours worked x 1.6% + \$0.01 + \$0.20 per hour.

NOTE – <u>after final allocation calculation the SASMI is \$0.06 per hour. This change was noted in the Allocation</u> <u>special meeting notice the additional \$0.01 has been added to wages.</u> The actual SASMI rate is 3% of the base hourly rate plus contributions to all pension, annuity, and health & welfare funds.

Other information your payroll dept. should be aware of:

Shift differential is 10% above the normal hourly rate.

APPRENTICE GRADUATED WAGE SCALE

Classified Worker, 1st, 2nd, 3rd and 4th term apprentices do not participate in our annuity program. The <u>**\$ 5.75**</u> p/h contribution into the Annuity is added to the base wage before the wage percentage is applied, therefore, their percentages are based on <u>**\$44.40 p/h.**</u>

Classified Workers – 45%; 1st term – 49%; 2nd term – 53%; 3rd term – 55%; 4th term – 57% (see paragraph above for the correct calculation)

5th term – 62%; 6th term – 65%; 7th term – 70%; 8th term – 75%; 9th term – 80%; 10th term – 85%. **(based on \$38.65 p/h)**

Carfare – Mileage is adjusted to the **2023 IRS Allowance**, listed at **\$0.635 per mile - Effective 6/1/23.** The free zone is 30 miles from contractor's shop or member's residence, whichever is closer to job site.
